## **Log Files**

3D Realm s.r.o. follows the standard procedure of using log files. These files record visitors when they visit websites. All hosting companies do this and it is part of the analysis of hosting services. Information collected by log files includes Internet Protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any personally identifiable information. The purpose of the information is to analyze trends, administer the site, track user movement on the website and gather demographic information.

## **Cookies**

Like any other website, linami.sk also uses "cookies". These cookies are used to store information including the visitor's preferences and the pages on the website that the visitor has visited or visited. The information is used to optimize the user experience by customizing the content of our website based on visitors' browser type and/or other information.
